Abstract: My dissertation investigates the role of empathy in mitigating the harms that fraught moral and political conflict can cause. First, it answers normative questions such as: What sort of relationship should we seek to have with our moral and political opponents? What role should empathy play in promoting such relationships? Second, it proposes a set of strategies for fostering empathy and the relevant kinds of relationships. Finally, it offers solutions to ensure the adequate and equitable distribution of empathic capabilities across different sectors of the population.
